**Entrance.** Currently, as in all areas of our Republic, major reforms are being implemented in the field of education. In particular:

In accordance with the Decree of the President of the Republic of Uzbekistan No. PF-82 dated June 1, 2023 "On comprehensive measures to provide high-quality social services and assistance to the population and establish an effective control system for them", the adoption of

a resolution of the National Agency for Social Protection under the President of the Republic of Uzbekistan on the establishment of the State Fund for Social Protection and the approval of the directions of expenditure of the fund's funds is a clear proof that people in need of social protection are not indifferent to our country.

The humanization of social structures based on new principles, the laws of the market economy, changes in ideological and moral principles lead to unemployment, material deprivation, lack of control over children, and family separation; non-social phenomena: alcoholism, drug addiction, crime, etc. are also the basis for developing measures and events aimed at finding solutions to social problems. In this case, first of all, children, and then adults, need social assistance. In such conditions, a demand has arisen for a social pedagogue as a specialist who solves pedagogical issues related to the social problems of society and helps the individual in the process of his socialization. Main part. Although the social adaptation of children has previously existed in our country in the form of "social education", social protection", "social assistance", this process is being deepened as a field of pedagogical knowledge and a science. The reasons for its becoming an independent science, but the lack of systematization of practical experience, are explained by the complexities and contradictions of the historical development of Uzbekistan. The events that negatively affected social pedagogy include the discrediting of social education that began in the 1930s, the emergence of an "iron curtain" that separated local scientists and educators from foreign experience and foreign colleagues, the replacement of universal human values with class values, the policy of silence about social problems, the destruction of traditions of compassion and kindness. Today, interest in social pedagogy is being formed based on the needs of social development and the social order of the state.

From July 1, 2023, groups of social workers will be established in the "Inson" social service centers.

By October 1, 2023, the "Unified National Social Protection" information system will be launched.

On August 15, 2023, the practice of informing the population about social services and social assistance programs, including by sending information to their mobile devices, was introduced.

From August 1, 2024:

From February 1, 2024, in specialized preschool educational organizations, schools, boarding schools in Tashkent;

From January 1, 2024, "Social assistance and assistance provided through donations and assistance will be covered.

From August 1, 2024, in preschool educational organizations, schools, boarding schools in the remaining regions of the republic.

From April 1, 2024, in specialized preschool educational organizations, schools, boarding schools in Tashkent region;

Resolution No. 46 of the Cabinet of Ministers of the Republic of Uzbekistan dated January 25, 2024 "On measures to improve the system of organizing and rehabilitating children with special educational needs" was adopted. In accordance with the resolution, short-term "Care" groups will be established in specialized educational organizations for children with severe health problems who need special education. "Care" groups:

"Care" groups are being organized to provide short-term (up to 4 hours) care, education and upbringing of children with special educational needs who are not accepted into specialized educational institutions, and to assist them in their adaptation to society.

The Agency is an authorized state body for the development and implementation of a unified state policy in the field of social protection of the population and the provision of social services and carries out its activities independently of other state bodies and organizations, their officials. Tasks of the Agency: The mission of the Agency is professional social service and social assistance.

On the basis of the medical, psychological, pedagogical, commission on the admission of children with special educational needs to state preschool educational organizations, and the psychological, medical, pedagogical commissions on the admission to specialized schools and boarding schools, unified psychological, medical, pedagogical commissions are established under the departments of the National Agency for Social Protection of the Republic of Karakalpakstan, regions and the city of Tashkent.

Rehabilitation departments for children are launched.

- -Conclusion of the Medical and Social Expert Commission on the child's disability (if any);
- -A narrow specialist conclusion depending on the child's diagnosis: a conclusion of a psychoneurologist, approved in accordance with the procedure established by the legislative documents of the psychoneurological center (only for children with speech, mental and intellectual disabilities);
- -A certificate and a description of the child's place of study, reflecting a detailed analysis of the duration of education, mastery of academic subjects and behavior, measures taken to provide individual support to the child (for children studying in educational institutions).

Today, a number of decisions are being made to create a number of opportunities for children in need of social protection. In particular:
